

INCORPORATING MANAGEMENT OF HEALTH & SAFETY AT WORK REGULATIONS

**RISK ASSESSMENT Part 4 COVID-19 and TEST & TRACE**

1.	Handlers <b>MUST NOT</b> attend if from an area in government imposed 'lock down' or to have suffered any symptoms, tested positive or have been self-isolating of C-19 for <b>28 DAYS PRIOR</b> to and up to the date of event. You <b>MUST NOT</b> travel or attend if you begin to feel unwell or show signs of symptoms on the morning of this event. (a list of symptoms are listed as below).
2.	At the venue please <b>PARK YOUR VEHICLE CONSIDERATELY</b> ensuring a safe distance to enable adequate loading and unloading of dogs.
3.	Handlers must each provide two marked dummies. <b>ONLY ONE HANDLER PER DOG ALLOWED</b> ; you may be accompanied by one other person from the same household. <b>DO NOT</b> hold someone else's dog at this event.
4.	<b>TWO CLEANING STATIONS</b> will be provided: <b>(1)</b> for trainers/dummy throwers/officials, <b>(1)</b> for handlers. It is recommended that handlers provide their own but there will be hand sanitiser, anti-bacterial wipes, disposable gloves, anti-bacterial sprays, anti-bacterial hand soap and water plus paper towels available at each of these stations. Please dispose of paper towels in the bin/s provided.
5.	<b>NO FACE COVERINGS, NO ADMISSION.</b> Please <b>PROVIDE YOUR OWN FACE COVERING, MASK OR VISOR</b> for your own safety, <b>DO NOT</b> lend to anyone else at this event. Face coverings may be removed when running a dog but must be replaced when a dog is picked up. Care must be given to replace immediately if speaking to a Judge or Trainer.
6.	Please keep a safe <b>2 METRE DISTANCE</b> from any other handlers/trainers/dummy throwers/officials throughout the event. <b>NO PHYSICAL CONTACT IS ALLOWED.</b>
7.	Dummy throwers are recommended to wear disposable gloves which may be changed regularly and after each or any break.
8.	<b>NO REFRESHMENTS WILL BE AVAILABLE</b> , please bring a packed lunch and drinking water for your dog. Luncheons and drinks <b>MUST NOT</b> be shared with others.
9.	A pre-packaged luncheon (purchased from a retail outlet) will be provided for trainers, dummy throwers and officials.
10.	All handlers, trainers and dummy throwers to have completed the ' <b>TEST AND TRACE</b> ' form at the foot of this Assessment (to be accompanied with entry form where applicable). Failure to return with entry form will result in you being turned away.
11.	Toilet facilities at the venue <b>MUST BE</b> respected (if available); please use the anti-bacterial spray provided in the wash area. Spray the toilet seat and handle after each use and wash your hands thoroughly for at least 20 seconds. Facilities at the training location will be 'alfresco'. <b>PLEASE DISPOSE OF ANY WASTE TISSUE IN THE BIN/S PROVIDED.</b>
12.	A <b>COVID-19 REPRESENTATIVE/SAFETY OFFICER</b> will be identified to you on the day during the health and safety briefing prior to commencement of this event.
13.	Payment for entry will be as per entry form details only. <b>STRICTLY NO PAPER ENTRIES OR CASH</b> on the day to prevent possible transmission.
14.	Please ' <b>PICK UP</b> ' after your dog to ensure we may use this venue again.
15.	<b>YOU MUST CALL 119</b> or visit <a href="http://www.nhs.uk">www.nhs.uk</a> <b>AND</b> the organizer immediately if you develop or experience C-19 symptoms as a result following this event (a list of symptoms are attached as below).
